It is understood that this agreement will be a continuing one, and is shall cover all bills and invoices rendered by RGG under the terms and conditions stated herein and under said invoices. The applicant does hereby waive notice of any demand by RGG as well as any notice of default in the payment of any amounts owing according to the terms of the invoice. RGG also reserves the right to place the debtor on "Stop Ship" or "C.O.D." without notice, in the event of default or for any other reason. RGG may discontinue or stop delivery or sale to applicant at any time and for any or no reason. If any suit or action is filed by any party to enforce this Agreement or otherwise with respect to the subject of this Agreement, venue shall be in the federal or state courts located in Douglas County, Nebraska. Applicant and guarantor hereby consent to jurisdiction in the federal courts of Nebraska. The prevailing Party in any claim, action or proceeding to enforce or interpret this agreement will be entitled to costs and reasonable attorneys' fees, at or before any trial and/or appeal; and the costs of collecting any judgment obtained including any costs or attorneys' fees incurred in any bankruptcy proceeding.
